Circular to Members who have Wind Mills in TN



Dear Friends

**Update of information regarding verification of captive status of the CGPs and implementing of new energy accounting procedure for wind energy captive users
-Honourable Madurai Bench of Madras High Court orders dated 25.05.2017**

Some of the captive wind energy generators who were affected by the CGP verification process of TANGEDCO had filed a petition with the Honourable Madurai Bench of Madras High Court.

The cases came up for hearing and the following orders were issued on June 08, 2017.

(i). In W.P.(MD). Nos.9304 and others (M/s Sugapriya Paper & Boards (P) Ltd., Vs. TANGEDCO and others)

(ii). In W.P.(MD).No.9320 of 2017 and others (M/s NuPower Wind Farms Limited Vs TANGEDCO and others)

The above-mentioned orders are attached for members perusal.

It may be observed that the Honourable Court has ordered that on filing of appropriate petitions by TANGEDCO, the TNERC shall dispose of both the matter of verifying the captive status of the CGPs and implementing the new energy accounting procedure for wind energy captive users within a period of twelve weeks, by providing suitable opportunities to the stakeholders.

The Honourable Court has also ordered that in view of the consent provided by the Additional Advocate General representing TANGEDCO, to take up the matter before the TNERC all the impugned Circulars and Memos issued by the TANGEDCO in connection with verification of captive norms and implementing the new energy accounting procedure for wind energy captive users shall be kept in abeyance.

It is felt that the cases related to verification of captive norms filed by our Association and others in the Honourable Madras High Court may get similar disposal when it comes for next hearing.

As directed by the Honourable Madurai Bench of Madras High Court, it is understood that the TANGEDCO has issued circulars to their field officers to keep in abeyance all their circulars already issued on the subject matters.

Therefore, all the Members are requested to wait till the disposal of this case by the Honourable TNERC on filing of petition by the TANGEDCO. The Association will communicate and advise the Members on new developments as and when required.
