## Circular to Theni REGEN WEG Owners - AMC for 2019 -20

Dear REGEN WEG Owners in Theni,

Greetings to you All.

During our earlier discussions, all of us agreed to have a smooth flow of Annual Maintenance Contract of REGEN WEG's we have in Theni. In continuation of such idea, I met Mr.Madhu Sudan Khemka, CMD of REGEN at a wedding in Chennai yesterday, 22<sup>nd</sup> April 2019 and discussed with him.

Most of the difficulties that arose in the Year 2018 -19 was due to

- The pressure of lenders of REGEN on the financial inflows and
- 2. The non payment / delay in Monthly salaries and rental in the field at Theni

So the WEG Annual Maintenance amount will be divided in to two.

- A. The amount needed for disbursal by REGEN at Theni towards salaries to watchman, transport owners, SCADA operators, Mechanical & Electrical support employees and the alike.
- B. REGEN will let the WEG owners know the amount needed for such disbursal at Theni.

The WEG owners will send that part of payment in 4 instalments to Theni payable to "REGEN Theni WEG owners Annual maintenance joint venture account " and balance to REGEN to Chennai also in 4 instalments. The idea is acceptable to Mr.Madhu Sudan Khemka, CMD of REGEN.
