IWPA Circular No. 276 of 2019

Circular to Members having wind mills in Tamil Nadu



Dear Member

AMR Project - Implementation of OA Software

Discussions the Association had today with the Chief Financial Controller (Revenue) TANGEDCO

Further to the TANGEDCO's Memo No. CFC/REV/FC/REV/DFC/AAO/HT/D.95/19, dated 14/02/2019 forwarding therewith the guidelines for operating edit provisions in the master data, we have been receiving representations from our members regarding issues in correcting the Master data. Some of them are given below.

1. Service Details

(a) REC / non-REC information is not editable (b) unable to add email ids (c) feeder name is blank

2. Meter Details

Editing provision in respect of meter details is not given. The reason given is that this data is taken from NCES-AMR database. Hence corrections should be carried out with concurrence of the NCES – MRT Team.

3. WEG Details

No editing option for the make, model and no. of units.

4. OA Consumer Details

Though the service number is correct, the company name is incorrect. Sometimes the quantum in MW capacity is incorrect. The "from" / "to" date of agreement is incorrect. All these corrections are not enabled.

Some members have complained that after carrying out the corrections, the corrected data is not displayed or is wrongly displayed. All the above issues were discussed with the CFC Revenue.

The CFC Revenue gave a patient hearing and has requested us to convey to all our members that this month the priority should be to ensure that the mandatory fields which affect billing are correct. The rest of the discrepancies in the data can be corrected in the course of time.

Members are requested to ensure that the mandatory fields which directly affects the billing to be corrected immediately. The CFC Revenue has assured us that all other corrections would be carried out immediately after the billing is generated. She has also assured us that any discrepancy in the amount would also be adjusted in this month itself or before the next month billing. It is learnt that by this evening, edit option for banking would also be carried out. **If the Master Data (mandatory fields) are found to be correct then members are advised to immediately proceed with the allotment through the OA software to the captive users and inform them as well.**

Members are requested to give their fullest cooperation for the success of the AMR Project to reap the attendant benefits.
