IWPA Circular No. 5 of 2020-21

Dear Member,

Sub: Update of Outstanding Payment of arrears by DISCOMs on the basis of details uploaded by Sale to Board / DISCOMs on PRAAPTI app

Ref: IWPA Circular No. 3 of 2020-21 dated June 8, 2020

This further to IWPA Circular No. 3 of 2020-21 dated June 8, 2020 (Annexure A).

Following the above-mentioned Circular, some members had represented that the PRAAPTI App was not functional. IWPA immediately raised the issue with the Nodal Agency concerned and it was set right within two days. Whilst several members subsequently uploaded their data, a few represented that they were experiencing difficulties. IWPA collated and sent the data to the nodal agency and received the following response:

"Dear Sir,

We have rechecked with our tech team and updated the status for each generator in the excel file provided.

Our team has ensured that we respond to each and enquiry that we are receiving from the generators. However if they still have any unresolved issues which may not have been communicated to us then I would request them to kindly email us with their issues on pfcccl.app@cruxbytes.com.

We will be more than happy to help them onboard quickly."
