Sub: Submission of documents for CGP verification by members having WEGs in Tamil Nadu for captive use – TNERC order regarding data submission to TANGEDCO

Members are aware that the Tamil Nadu Electricity Regulatory Commission passed an order dated January 28, 2020 in RA 7 of 2019 regarding the procedure to be followed in respect of data submission to TANGEDCO for verification of CGP status.

Our Association has filed a clarification petition before the Honble Commission in MP No 24 of 2020 seeking to clarify a few points.

In the hearing held on 13.10.2020, Honble **TNERC has given a direction to all the CGPs to submit the documents before 31.10.2020 as prescribed under RA 7 of 2019.**

Members are advised to submit the documents within the stipulated time as under

In this connection, members are advised as under:

- Where a member owns 100% of one or more WEGs situated in one or more generating circle and uses it for own captive purposes at one consumption point, both generation and consumption data is to be submitted IN AGGREGATE for all the machines, even if each WEG has a separate HTSC number. The documents can be submitted at the SE EDC of the consumption end. Copy of the acknowledgement(s) issued by the SE EDC of the consumption end for submission of documents may be submitted with a covering letter to the SE EDC of the generating circle.
- Where a member owns 100% of one or more WEGs under one legal entity situated in one or more EDCs (generating circle) and consumes it at multiple HTSC in one or more EDCs for own captive purposes, data is to be submitted IN AGGREGATE of all WEGs at the consumption end to the SE EDC where the member has maximum consumption. Copy of the acknowledgement issued for submission of documents may be submitted with a covering letter to the SE EDCs of the generating circle from where notices were issued as a proof for submission of documents and obtain acknowledgement or send it by RPAD.
- Group captive generators having one or more WEG installed in one or more EDCs and having one or more captive user, data is to be submitted in Aggregate at the generating end EDC where maximum installed capacity of the CGP are located. Acknowledgment should be obtained while submitting the documents. Where notices have been received from more than EDC calling for documents and particulars, copy of the acknowledgement may be submitted to other EDCs as well.

- Members may please note that the Hon'ble Commission has directed to provide details in Aggregate and hence members may aggregate the generation from all WEGs and consumption of each captive user for the whole year and submit accordingly. Members are also advised to get the acknowledgement of the documents or send it by RPAD and keep the Acknowledgment safely.
- Members are advised to compile the data as above and submit the documents before 31st October and in order to avoid last minute rush, members are advised to submit by 29th as 30th October is a public holiday.
- Members are further advised to submit documents for each financial year separately with a covering letter as per format attached to this circular.

Based on a petition filed by another Association before the Hon'ble APTEL challenging some procedures of the RA 7 of 2019, hearings took place and the final orders have been reserved. Members would be advised of further developments if any in this matter
