IWPA Circular No. 15 of 2024-25
(For members based in Madhya Pradesh and
having windmills in Madhya Pradesh)



Dear Member,

Sub: Formation of Madhya Pradesh State Council

At the Seventh National Council Meeting of the Association for 2023-24 held on May 15, 2024, it was decided to form State Councils in Tamil Nadu and Madhya Pradesh. In line with this decision, the Tamil Nadu State Council was formed in August last year. We now propose establishing the Madhya Pradesh State Council.

As of 31st December 2024, Madhya Pradesh has a total installed capacity of 2,844.290 MW. Out of this, IWPA members own 1,883.850 MW, which is over 66% of the total installed wind energy capacity in the state.

We now plan to have a formal meeting of members who are based in Madhya Pradesh and have installed windmills in Madhya Pradesh for the launch of the State Council and for selection of the Council Members. The meeting is scheduled to take place on 7th February 2025. The venue and time of the meeting will be intimated in due course.

In order to set the ball rolling, **we invite nominations for membership of the Madhya Pradesh State Council.**

As per IWPA Byelaws:

1. The Council shall have Fifteen Members, out of which at least two thirds shall be exclusively generating members.
2. All Council members shall have paid their subscription till date.
3. Once the State Council is formed, the Council members shall nominate from among themselves the Office Bearers - President, Vice President, Secretary and Treasurer.
4. For Office Bearers, only generating members not engaged in sale or manufacturing of machines or spares are eligible.
5. The term of office shall be three years. However, from the second year onwards, one third will retire and elections will be held for those who have retired. For the first two years, retiring members will be decided by drawing lots. Thereafter, the senior members will retire by rotation and election will be held for those vacancies and other consequential vacancies, if any.

We would request that those who are interested to volunteer to be State Council Members to send in their nominations in the attached form on or before 29th January 2025 before 05:00 p.m. to the email: iwpahq@windpro.org
