

Renewable Energy Commitment by members for the five year period 2015-19

The Government of India has set ambitious targets for renewable energy. MNRE had issued an advertisement on January 31, 2015 in terms of which a target of 60 GW of Wind Energy would be installed in a span of seven years i.e. by 2022. As you are all aware, the First Renewable Energy Global Investors' Meet (RE-INVEST) is being organized at New Delhi on February 15th, 16th and 17th 2015 to attract investments in the RE Sector. This programme would be inaugurated by the Hon'ble Prime Minister.
