Making Wind Energy Evacuation better in Tamil Nadu

TANGEDCO agrees NIWE to be the forecaster

IWPA agrees to install infrastructure by May 31, 2015 – Looking for your early contribution

Thanks to the overwhelming response at IWPA's meeting in Coimbatore on April 09, 2015, the matter regarding the wind generators sponsoring the installation of communicating ABT energy meters in all TANGEDCO's wind energy pooling sub-stations (around 134 sub-stations), modem and centralised server at Chennai which would consolidate and play real-time wind generation data and display in the monitor before the Tamil Nadu SLDC grid manager and the forecaster, the National Institute of Wind Energy (NIWE) Chennai, was discussed.

The meeting was jointly convened by the three Associations viz. IWPA, TASMA and SIMA which was well attended by nearly 100 members. TASMA was represented by its President Shri Appukutty; SIMA was represented by Shri S V Arumugam of the Bannariamman Group who also happens to be the Vice Chairman of IWPA. IWPA was represented by the undersigned, the Chief Technical Advisor Shri A D Thirumoorthy, the Treasurer, Shri Raja Sukumar and a few National Council Members. It was decided that every wind generator would contribute a one-time amount of Rs. 15,000 per MW before April 19, 2015. Members of all the Associations have unanimously decided to make this contribution to IWPA. The first cheque was received from Pollachi Shri Sekar in the meeting itself.

Those who spontaneously agreed to send the payment include, The Ramco Cements 300 MW; Mytrah Energy 101 MW; Beta Wind Farms 314 MW; Leap Green 168 MW; Premier Mills 108 MW; Shanmugavel Group 270 MW; Arvind Green Infra 38 MW; Green Infra 108 MW; IL&FS 48 MW; KRBL 8 MW to name a few. Since time is of the essence, the payment may please be made within a week based on the installed capacity of each of your individual company / group companies to the following account.
