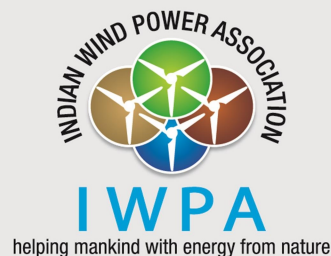

**Sub: Interactive Meeting on Notifications by TNERC & TNSLDC**
