## Sub: Sale of Carbon Credits / VCS Credits

As you may recall, IWPA took up the initiative to benefit our members on sale of carbon credits which predominated in the year 2008. Accordingly, as desired by majority members we had fixed up M/s. Deloitte India to facilitate the sale. Many of our members showed interest in the scheme and volunteered to sell VCS (Verified Carbon standard) a modified form of carbon credit and had their wind farms registered.

As per M/s. Deloitte, only 8 bundles of VCS of 70.305 MW of only 58 members could pass the stringent statutory norms of the foreign buyers and got registered. These 8 bundles were sold through Deloitte and these registered wind farms got the VCS money.

After 2009 there was a lull period on sale of VCS and foreign buyers were practically nil. Recently, buyers have come to buy our generation from the year 2009 to 2016 from the same registered wind farms (VCS Project).

Now we wish to expand the area so that those members who had not registered from the year 2009 to 2016 and also those members from 2017 to 2022 can join. These two schemes those already registered and those yet to be registered will be dealt separately.
